#### Website;

The website is now live <a href="www.frodshamplan.org.uk">www.frodshamplan.org.uk</a> and includes a short survey, the password for accessing the responses was provided. All to review the site and comment

## <u>Public Events</u>;

It was agreed the next public event would be on 11<sup>th</sup> February 2017 at the Parish Hall, this would be an engagement event.

#### **Questionnaire**;

A meeting with Richard Thresh from CCA has been arranged for 6<sup>th</sup> December at 1.30pm to discuss developing questionnaires for landowners and employers. The grant funding allows for the writing and analysis of two questionnaires.

#### **Networking meeting**

PV, CA & GH attended a free NP networking event run by My Community in Macclesfield on 15th November. All found it very useful and informative, the main learning points were;

- 1. The importance of the vison as a touchstone for all the plan policies, ours stood up well against other examples
- 2. We need to produce four documents; a map of the NP area (completed), a consultation document (who we spoke to), the plan itself (detailing the policies) and a basic conditions statement (how the plan fits with national and local plans and policies).
- 3. The difference between "consultation" (the formal questionnaires and data) and "engagement" (the identification of people's ideas and issues and getting the community on board)
- 4. Using the expertise and experience of the local Planning Dept, who are duty bound to assist us, and who we ignore at our peril!
- 5. Most plans overdo the evidence, we need to provide specific, relevant evidence for Frodsham, rather that reiterate evidence from public sources

## **Policies**

The meeting agreed the next step was to draft policies and that housing and green space / open space / green belt were the priorities. It was noted that many good ideas could be gained from other plans, and the My Community resources were very useful.

A process of finding out who owns what land in Frodsham is underway; the aim is to ascertain what CWaC owns, what FTC owns, what the Church owns, and other individual land owners.

### <u>AOB</u>

Pam Bradley, locality Officer with CWaC requested a meeting with PV and GH which was held on 23rd November. Pam was given an update on progress so far and offered her help and support.

PV had found out that FTC have a public-sector mapping agreement which means we can access any appropriate local maps for events and information.

GH circulated an invitation to a planning update event run by CHALC to be held on 30<sup>th</sup> January 2017 in Christleton.
