**Frodsham East - Proposed 20mph Speed Limit**

In January 2016 the Council's Cabinet voted to introduce 'signed only' 20mph speed limits, where appropriate, on all residential roads and outside schools.

Your road has been assessed and meets the criteria for a 'signed only' 20mph speed limit along with other roads in your area, which are highlighted in blue on the attached plan.

Traffic calming measures will not be included.

Cheshire Police have no objections to the 20mph speed limit proposal.

A Traffic Regulation Order for the new speed limit will be advertised during week commencing 3<sup>rd</sup> September 2018 until 28<sup>th</sup> September 2018.

All objections and other representations relating to the Order must be made in writing to the undersigned or by email to the address below by 28<sup>th</sup> September 2018 and objections must specify the grounds on which they are made.

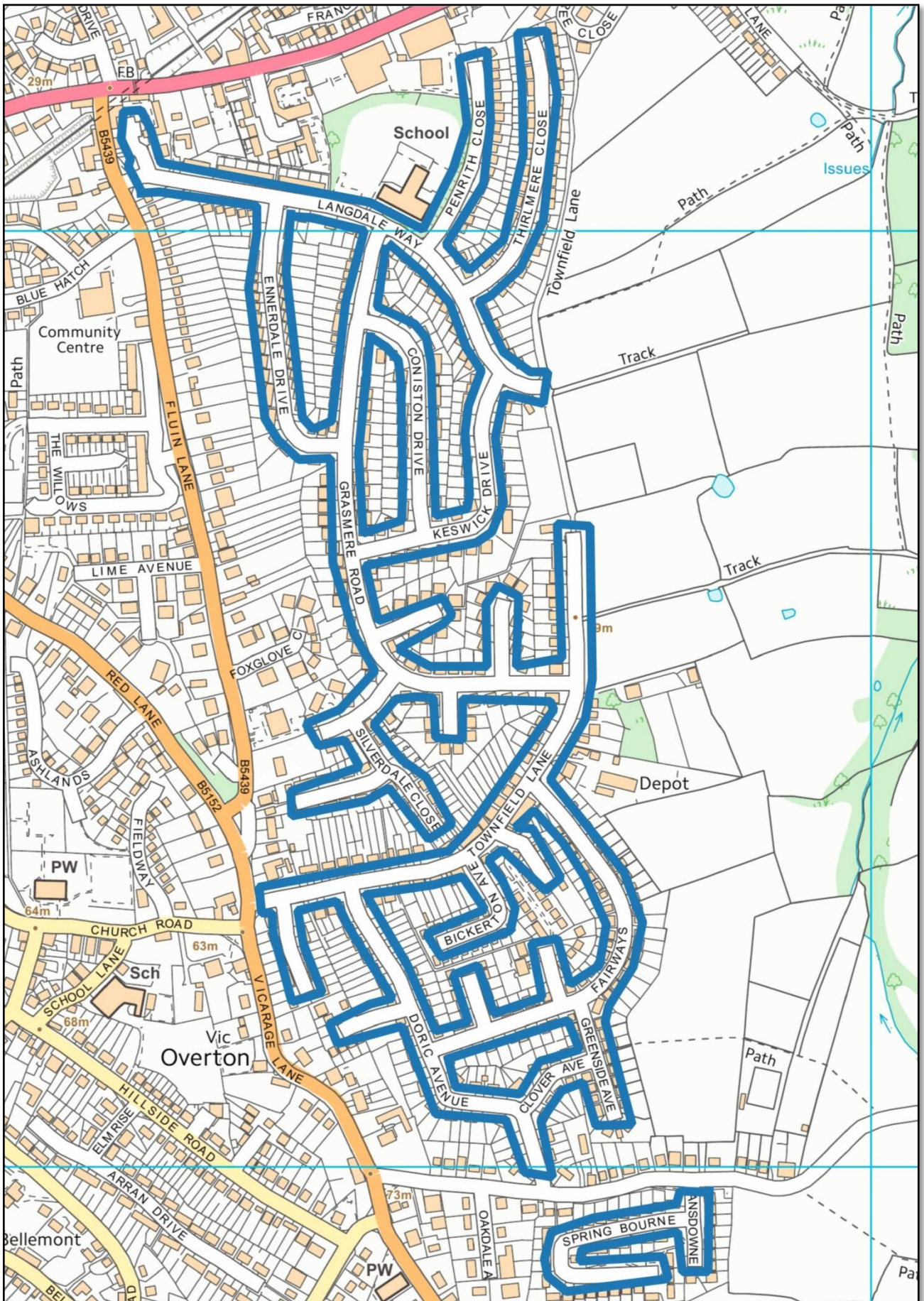

## **Frequently Asked Questions – 20mph Consultation**

### **1. Why are the council proposing a 20mph speed limit in my area?**

In their manifesto at the last election the leading party on the council promised to introduce 20mph speed limits across the borough.

In January 2016 the council voted to introduce 'signed only' 20mph speed limits on residential roads that met Department for Transport criteria and to include schools on through routes that met criteria.

The programme will take four years to deliver.

### **2. How much will the proposals cost for my area?**

The proposed areas differ in size; therefore it is difficult to give an exact cost for each area at this stage.

There are 225 identified schemes and the overall budget over four years is £800,000, it is estimated that each area will cost between £1,000 and £6,000 but this is only a rough guide at this stage.

### **3. Why is my road included within the proposed 20mph speed limit?**

Your road has been included in the 20mph proposals because it meets the criteria for a 'signed only' 20mph speed limit. To meet the criteria roads must have an average speed below 24mph.

### **4. Why have some roads not been included in the proposals?**

Roads with average speeds above 24mph do not meet the criteria for 'signed only' 20mph speed limits and have not been included in the programme; these roads would require traffic calming or other engineering measures to ensure compliance with a lower speed limit.

### **5. Do the proposals consist of traffic calming or other physical measures?**

The proposals do not include traffic calming or physical measures such as speed humps.

Roads that require traffic calming or other measures will not be included in the programme.

### **6. You haven't included roads with known speeding problems.**

The purpose of the 20mph programme is to introduce appropriate speed limits on roads that meet criteria.

Speed limits are not used to deal with problems of speeding motorists; which are addressed using engineering measures or enforcement.

Roads requiring engineering measures are not included in the programme. There are different procedures and programmes to deal with speeding issues.

### **7. How is the proposed 20mph speed limit going to be enforced**

As with all speed limits, the proposed 20mph speed limit will be enforced by the police based on evidence of a speeding problem.

The proposed scheme in your area is to be introduced on all roads that meet the criteria for 'signed only' 20mph speed limits; with average speeds below 24mph compliance should not be an issue.

To ensure that compliance is being met, should the scheme go ahead, all speed monitoring will be repeated and any evidence of non-compliance will be used by the police to prioritise their enforcement programme.

### **8. You have included short Cul-de-Sac roads where it would be impossible to speed.**

The purpose of the 20mph programme is to introduce appropriate speed limits even where it is difficult to exceed the speed limit.

If Cul-de-Sac roads, which lead off roads with a 20mph speed limit, were omitted from the scheme the council would be legally required to install 20mph and 30mph speed limit terminal signs at the access to the Cul-de-Sac roads. This would increase costs and lead to driver confusion and generate many complaints.

Short Cul-de-Sac roads, (less than 100m in length), that lead off roads with a speed limit of 30mph or higher, will not be included in the programme.
