Seats & Commemorative Plaques Policy

[In pursuance of Highways Act 1980 & Parish Councils Act 1957]

2021 - 2031

1 Background

- 1.1. In the early 1980s, Frodsham Town Council (FTC) resolved to provide roadside seats for the benefit of the people in each of its four wards and to install commemorative plaques on these seats in honour of deceased Councillors.
- 1.2. At the time of the opening of the Council's cemetery (1994), the Council resolved to allow bereaved families to install seats with commemorative plaques in the cemetery. On 27 July 2009, FTC approved the Amenities Committee's recommendation that no further seats be installed in Tarvin Road burial ground.
- 1.3. In the intervening period, 36 roadside seats and 10 seats in the burial ground have been installed.
- 1.4. Recently there have been requests for seats with commemorative plaques to mark the passing of loved ones.
- 1.5. In some ward there has been increased demand for seats to make lives easier for people with disabilities.
- 1.6. This document defines the Council's policy on seats & plaques for the next 10 years.

2 The Policy

- 2.1. *WHO Policy:* Frodsham is recognised by the WHO as an Age Friendly Borough. Our challenge is to consider every opportunity to support this international initiative which aims to consider the needs of residents of all ages. One thing we might wish to jointly explore is creating a network of seating arrangements at key locations around the town where people can just stop, rest a while and chat to anyone sharing the bench (post lockdown of course). Our Main St in particular is a long walk for some.
- 2.2. *Roadside Seats:* In view of its objective to provide seats in all four of its wards, FTC will work with the public to install additional roadside seats.
- 2.3. *Commemorative Plaques:* Subject to FTC's approval, mounting of commemorative plaques for deceased family. FTC will work with families to identify suitable seat or site for a new seat. Families will be asked for a contribution towards purchase, installation and maintenance. It is anticipated that such dedications will last for a maximum of 20 years to enable recycling etc. as required.
- 2.4. *Cemetery Seats:* FTC will allow installation of additional seats on the existing land as and when such sites become available. Families will be asked for a contribution towards purchase, installation and maintenance. It is anticipated that such dedications will last for a maximum of 20 years to enable recycling etc. as required.
- 2.5. *Maintenance of Seats & Plaques:* FTC will be responsible for inspecting and maintaining all seats & plaques with the exception of the seat in Main Street which is the responsibility of Cheshire West & Chester Council.

3 Publicity & Access

- 3.1. The Policy will be available from the FTC Office and on its website (www.frodsham.gov.uk).

4 Monitoring & Review

- 4.1. FTC will monitor the need for new seats & plaques and review this Policy on the basis of statutory/public benefit need.
