Review of Cemetery Fees

The cemetery fees payable at Tarvin Road Cemetery were last reviewed in 2019 when fees were increased by between 7% and 25%. The current fees are shown in the Appendix.

The Consumer Price Inflation (CPI) index increased by 11.2% from July 2019 to April 2022 (the latest available figure).

Generally speaking, Frodsham's fees are comparable to neighbouring cemeteries run by local councils, being higher than those charged by Weaverham and Kingsley and lower than Helsby.

The cemeteries run by unitary councils of Cheshire West & Chester, Halton and Warrington charge considerably more.

The figures are indicative and are not precisely comparable, as plot sizes may vary, and some may higher fees are inclusive of gravedigger costs.

^{**}For the purpose of this table of fees, the term 'Resident' is a person who, immediately before their death, was an inhabitant of the Town of Frodsham. Those persons living outside the Town will pay Non-Resident fees.

The term inhabitant shall be any person living in Frodsham at the time of death or having lived here within a five-year period or 90% of their life (whichever is the greater). All others are classed as 'Non Residents'.

There is no interment charge for children one year old or younger.
